The role

- Implement best practices and develop, execute, and enforce critical company policies and procedures (i.e., travel policy, purchasing policy, etc.)
- Lead annual budgeting cycle and associated reporting and analytical decision support
- Support in subsidy and grant applications (budgeting) and assure grant/subsidy compliance
